




#### 1. Lead (Pb), Cadmium (Cd)




#### 2. Mercury (Hg)



#### 3. Hexavalent Chromium(Cr(VI))




#### 4. Polybrominated Biphenyls(PBBs), Polybrominated Diphenyl Ethers(PBDEs)
